Section 1 – Innovation and Transparency

Describe your top three E-Government IT accomplishments related to Open Government and innovation from this year and provide URL(s).

Three initiatives identified in the Department's Open Government Plan have now been implemented. These are described below.

As its "flagship initiative," the Department pledged a new "FOIA Dashboard" to enable the public to track and measure FOIA compliance for all 97 agencies subject to the Freedom of Information Act (FOIA). Launched in March, 2011, the FOIA site, found at http://www.foia.gov, serves as a comprehensive public resource for government-wide FOIA compliance data. It displays graphically all the information contained in an agency's annual FOIA report, including the numbers of FOIA requests made and processed by each agency, the disposition of those requests, the time taken to respond, and any backlogs of pending requests. Agency data can easily be compared and contrasted. Users can select the criteria they want to examine and then run custom reports. The Department also generates reports that would be of interest to the public and includes those on the site.

The Department made available to the public for the first time an array of documents for public review and research. These documents serve as a treasure trove to librarians, researchers and anyone else interested in the department's history and documents. In July, 2011, 28 digitized legislative histories were posted on the DOJ website for public use. These histories track the development and passage of laws that were deemed of interest to the Department or in which the Department played a vital role. Another four digitized extensive legislative histories from the DOJ library staff's collections will be added in the near future. Also of interest to the public are the Attorneys General Speeches. In July, 2011, the Library Staff began posting thousands of digitized pages of Attorneys' General speeches dating from 1933 to 2009. Currently, the speeches of 26 of the 82 Attorneys General are now available on the Department's website for public use, with more planned to be added in the near future. The DOJ Enterprise Architecture (EA) is an integrated, agency-wide blueprint designed to help DOJ use information technology resources more efficiently and effectively, and to improve the delivery of DOJ's critical mission programs. The Department Transition Strategy and Sequencing Plan (T&S) documents the DOJ progress towards the Target Enterprise Architecture (EA). The goal of the T&S is to clearly articulate Segment performance and provide a summary of modernization activities. The intent of the T&S is to enable better management of DOJ systems and programs against agency-wide plans. The T&S Plan also shows how the Department's investments will address performance gaps and work to improve DOJ capabilities; driving the Department towards the Target Architecture. The EA and T&S were already provided to OMB.

In FY 2011, the Department continued its support of the OMB-sponsored E-Gov Initiatives and Lines of Business (LOBs) solutions and/or services including those DOJ adopted in previous years. To update last year's report, below are descriptions of the Department's accomplishments with the following E-Gov Initiatives and LOBs:

Enterprise Human Resources Initiative (EHRI) – Efforts continue with migrating from paper Official Personnel Files (OPFs) to EHRI eOPF. To date, three DOJ components have implemented eOPF, four components are in the implementation phase of eOPF, and the remaining components are scheduled to reach compliance by the end of FY 2012.

E-Travel - Efforts continue with the ETS deployments and is partially using the end-to-end ETS solution for travel. DOJ has realized an increase in on-line booking for ETS users from 62% to 65% and a savings of approximately \$488,000 for FY11. During FY 2011, the Department expects to process over 8,000 vouchers at a cost of \$112,000.

Human Resources Line of Business (HRLOB) - Continue collaborating and implementing the HRLOB Multi-Agency Executive Strategy Committee (MAESC) guidance and HR

modernization roadmap. The Alcohol, Tobacco, Firearms, and Explosives and Drug Enforcement Agency migrated to shares service centers and continue to maximize the benefits of government-to-government commerce, and other DOJ components are exploring shared service center offerings.

Grants Management Line of Business (GMLOB) - With the support of Justice and the Office of Management and Budget, in FY 2012, OJP is planning, contingent upon Congressional appropriation, to begin a software refresh of Community Partnership Grants Management System (CPGMS). With completion of the refresh, OJP anticipates it will be in a sound position to offer grants management support services to other agencies.

In FY 2011, and continuing in FY2012, the CPGMS serves the OJP bureaus and program offices, Justice's Office on Violence Against Women (OVW), and the Department of Homeland Security's (DHS) Office of Grants and Training. Justice and DHS stakeholders include state, local and tribal governments, universities, non-profit organizations and individuals. These stakeholders benefit from one system that allows them to submit progress reports, financial reports, requests to modify the grant, and requests for payment. A consolidated grants system provides greater transparency in the grant process to all stakeholders.

Justice supports the objectives of the Grants Management Line of Business (GMLOB) Consortium initiative, which include reducing the number of systems of record for grants data across the government, developing common reporting standards, and improving agencies' ability to provide agency and government-wide reports on grant activities and results.

In FY2011, Justice's Office of Community-Oriented Policing Services (COPS) used its inhouse automated grants management system to process and award grants and will continue to use this system in FY 2012.

In FY2011, the Department of Justice (not including the independent Bureaus: OJP, EOUSA, USMS, EOIR, ATF, FBI, DEA, NDIC, BOP) submitted 20 records schedules for electronic information systems (EIS) that contain Federal records. According to ORMP's most recent records, the Department currently has 194 EIS (that contain Federal records), of which 159 have been scheduled (approved for final disposition) by the National Archives and Records Administration (NARA), and 25 schedules have been submitted by DOJ and are awaiting approval by NARA. To the best of our knowledge, only 10 EIS with Federal records are awaiting draft schedules from the DOJ Components which manage the systems. The DOJ has begun to plan and implement the use of digital signatures as part of the Department's compliance with the Federal Identity Credentialing and Access Management (ICAM) roadmap. To date, the DOJ has enabled a small number of Adobe PDF forms in production and digital signing pilots have begun within the DOJ enabling Adobe PDF documents to be signed using the PKI signing certificates present on the HSPD-12 card. Additionally, DOJ has established a technical infrastructure to provide long-term validation of digitally signed documents. In parallel, the DOJ is exploring implementing Digital Signing as a Service.

With one single online website, the Federal Docket Management System (FDMS) enables the Department of Justice to improve public access to all rulemaking material. Additionally it provides a central location for the public to find and comment on Justice regulatory actions that affect their lives. The components of DOJ with more active regulatory and notice programs are the Bureau of Alcohol, Tobacco, Firearms, and Explosives, the Civil

Rights Division, the Drug Enforcement Administration, the Executive Office for Immigration Review, and the Federal Bureau of Investigation.

2J. A description of how your agency has reduced errors through the use of electronic submissions.

The Department has been submitting its Office of Management and Budget (OMB) Exhibits 53, OMB Ex 300A and B, and monthly Federal IT Dashboard updates electronically to OMB through the Federal IT Dashboard. The Department uses the electronic Capital Planning and Investment Control (eCPIC) application to collect, validate, and submit its IT Budget and project management information to OMB. Beginning May 2011, the Department implemented a new eCPIC Data Exchange (EDX) process to more directly collect Investment IT budget information. The EDX process ensures consistency between budget documents and helps the Department and Component agencies minimize IT reporting inconsistencies and redundant data entry. This new process is used to collect the data used to produce the Department's OMB Exhibit 53.

2 K. A description of three key initiatives (provide specific examples) your agency is taking to comply with Section 508 of the Rehabilitation Act.

Three key Department initiatives to comply with Section 508 of the Rehabilitation Act follow:

1. The Department of Justice has established an Assistive Technology Resource Center (ATRC) within the Justice Management Division whose mission is to provide accessible electronic and information technology solutions to Department of Justice employees with disabilities. The ATRC works with

- organization managers and employees with disabilities who qualify for assistive technology to identify appropriate solutions, and assist with obtaining and installing the solutions, and assisting employees learn to employ those solutions.
- 2. The Department's Office of the Chief Information Officer, Internet Services Office leads regular meetings of a Department-wide Content Manager's forum. One of the key issues that this group addresses is ensuring that the Department's public and internal web pages comply with the technical requirements of Section 508. The Content Manager Forum share best practices, tools, and techniques for ensuring that web content is compliant.
- 3. The Department's Section 508 Coordinator reinvigorated the Accessibility Program by working with the department's components to identify Section 508 Points of Contact within each organization. These POCs served as the leads for obtaining responses from each component to the FY2010 Section 508 Compliance Survey. The results of the survey are being used to develop an Accessibility Awareness and Compliance training program. The objective of this training program is to raise awareness of the responsibilities of nearly every employee in meeting the requirements of Section 508.

2 L. The quantified cost savings and cost avoidance achieved through implementation of IT programs.

The Department of Justice has implemented several IT programs that have achieved cost savings and/or cost avoidance. Following are a few examples.

DOJ Transition from JUTNet to Networx. The Department of Justice awarded the Networx contract to manage DOJ's Wide Area Network, JUTNet, in July 2010. Pricing reductions went into effect as of November 1, 2010, providing the Department with a 14.3% savings per month in FY 2011, as compared to the legacy FTS2001 rates, resulting in a total FY 2011 savings of \$6.32M.

Justice Detainee Information System (JDIS) Consolidation. During FY 2011, the United States Marshals Service (USMS) completed a herculean, 16 month effort to modernize, secure, and standardize the agency's primary mission application, the Justice Detainee Information System (JDIS). This effort consolidated 94 disparate databases into one single data repository for both prisoner tracking and investigative operations, created business rules and data standardization, and a modernized web services architecture allowing for information sharing capabilities with other law enforcement agencies. The JDIS consolidation effort reduced server footprint by 90% allowing USMS to realize an estimated \$870K savings in operations and maintenance costs as well as a man-hour reduction of 15,000 hours. In addition, by converting the newly consolidated database from the obsolete and

unsupportable INFORMIX platform to the ORACLE database platform provided the USMS not only with a more reliable platform, but also with a projected \$990K in savings over the next three years resulting from leveraging the DOJ Enterprise license and support agreements for Oracle.

USMS Data Center Consolidation. The USMS relocated its primary data center to the new Drug Enforcement Administration (DEA) Data Center facility in Sterling, Virginia. The reasons for this move was both to satisfy the requirements of an Office of Management and Budget (OMB) mandate, and address inadequate resources to maintain production servers at USMS Headquarters. By moving to the DEA data center, USMS avoided the cost of upgrading their existing data center at USMS Headquarters. The projected initial power savings from this move is \$500K.

USMS Wireless Blanket Purchase Agreement. The USMS Wireless Blanket Purchase Agreement (BPA) with Verizon, Sprint, and AT&T continues to be recognized as the model for the Department of Justice. This year 16, 229 additional lines of service were added to the USMS BPA from other DOJ Components. Since the inception of the USMS Wireless Program in 2009, USMS has realized almost \$2M in savings.

OJP Telecommunication Services. In August and September 2010, the Office of Justice Programs (OJP), working with the Justice Management Division, changed the calling plan associated with Blackberry devices. OJP also removed outdated devices from inventory, and worked with individuals to re-confirm whether or not special Blackberry features were still needed. The cost savings and/or cost avoidance in FY 2011 was \$175K.

Department's eCPIC. The Department moved its capital planning tool, eCPIC, from the Justice Data Center hosting environment to the GSA eCPIC federal community cloud. By moving to the cloud, DOJ avoids eCPIC hosting and security costs. In 2011, the cost savings from this activity was \$28K.
